COOKIES POLICY

1. Introduction

EF Worldwide Ltd (hereinafter referred to as 'easyMarkets', 'Company', 'we', 'our', 'us' as appropriate) operating under the trading name easyMarkets is incorporated in the Republic of Seychelles, (Reg. No. 84227941), having its registered address at CT House, Office 9A, Providence, Mahe, Seychelles.

2. Scope of the Cookies Policy

The scope of this Cookies Policy is to provide you with information of how easyMarkets stores and access cookies through its site www.easymarkets.com ("Website") and all its related subdomains and mobile applications that are registered and operated by easyMarkets. This Cookie Policy does not apply to websites operated by other organisations and other third parties.

3. What are Cookies

Cookies are small text files that are sent to and stored on your device, such as desktop and laptop, smartphone, tablet/phablet, for accessing the internet, when you visit a website or a page. The cookie allows the website to "remember" your actions or preferences over time.

First party cookies are set by the website you are visiting. These cookies are set and controlled only by that website. Third party cookies are used in cases where the website is using external services which apply their own cookies.

Session cookies will expire at the end of your session on the website and are stored only until you close your browser. Persistent cookies will be used by the website and will remain valid until its set expiry date unless deleted by you.

Cookies do not typically contain any information that personally identifies you as a user, but personal information we store about you may be linked to the information stored in and obtained from cookies.

4. Why are cookies useful?



The cookies allow a website to recognise a user's device. The objective of cookies use is to improve and make the user's experience easier, safe and effective website.

An overview of the functions of our cookies are as follows:

- a. Verifying your identity and detecting which country you are located in;
- b. Checking browser type and device;
- c. Tracking which site the user was referred from;
- d. Allowing third parties to customize content accordingly.

5. Categories of Cookies stored on your device

The Website is using the below types of cookies for the purposes described below.

Necessary Cookies

Necessary cookies are required for the operation of a website (such as features and accessing secure areas of the site). Without these cookies, certain options on our Website may not be available. The essential cookies are vital for us to use for the quality of our services to you. The cookies settings are set by default to "Necessary cookies" every time you visit our Website.

Performance Cookies

Performance cookies analyse how our visitors use our Websites and also to monitor Website performance. These cookies do not collect any information that identifies our visitors.

Functionality Cookies

Functionality cookies allow us to remember your preferences and to provide enhanced or more personal features. These cookies remember the choices you made to improve your experience.



Behavioral advertising Cookies (third "3rd" Party)

Third party cookies are served by external companies through our website. Third party companies include social networks and advertising channels we use. These cookies store local information about your browser habits. Examples include liking a page, sharing information, viewing an advert and what browser/OS you are using. They help us measure the effectiveness of our advertising. Where applicable, you can opt out of these cookies and continue your browsing on our site. These cookies are outside of the control of the Company.

7. Manage your Cookies
